

# **PRIVACY NOTICE**

XPE Group NV and Adecco Professional Staffing NV (for more information: <u>"Legal Info"</u>), all with registered office at Noordkustlaan 16b, 1702 Groot-Bijgaarden, Belgium ("Spring Professional", "we" or "us") is committed to protecting and respecting your privacy.

This Privacy Notice (together with the <u>Terms of Use</u> on the Spring website <u>("Website"</u>) and other documents referred to herein) describes what personal data we collect from you and how we process your personal data.

If you do not wish to accept this Privacy Notice please do not continue.

## Information we may collect from you in compliance with applicable laws

For the purposes indicated below, we may collect the following personal data:

- Your personal details such as for example your name, address and post code, your birthdate, your phone number, email address, your work experience, your availabilities, references and skills in various areas and details about your education. It is also possible to upload your CV, cover letters and any other attachment which you consider useful to us or which we are asking from you.
- We collect your preferences to receive job alerts.
- We may collect information on your visits to the Website including, but not limited to, traffic data, location data, weblogs, content from surveys and contact forms and other communication data and the resources that you access. This information, for example, will make your visit to the Website easier in the future since we might suggest Content or Services depending on the location you access the Website from.

#### How we use your information

All this information ("your data") will be collected and handled by us for the following purposes:

- To perform studies and statistical and analytical research.
- In general to comply with any legal obligation.

# Third parties

To facilitate our efficient use of your data, and to provide you with the best services and/or opportunities, it may sometimes be necessary for us to disclose your information to third parties. However, this disclosure will only occur in the following circumstances:

- To suppliers, (sub-)contractors and agents: From time to time we may engage or employ other companies and individuals to perform functions on our behalf. Examples may include, administrative functions associated with our business activities. Such recipients will only have access to data required by them to perform their functions, and are not permitted to use such data for any other purposes. These recipients will be subject to contractual confidentiality obligations.
- To all Adecco Group Belgium Companies and other entities belonging to the Adecco Group (i.e. any companies directly or indirectly controlled by parent company Adecco Group AG, Sägereistrasse 10, 8152 Glattbrugg, Zwitserland –

# IP addresses and cookies

We may collect information about your computer, including where available your IP address, operating system and browser type, for system administration and to report such information in aggregated form to our advertisers. This is statistical data about our users' browsing actions and patterns, and does not identify you or any individual.

For the same reason, we may obtain information about your general Internet usage by using a cookie file which is stored on your device. Cookies help us to improve the Website and to deliver a better and more personalised service.



You may refuse to accept cookies by activating the setting on your browser which allows you to refuse the storing of cookies. This will remove all details from the cookie.
