



TERMS OF USE

OBJECT

These Terms of Use govern the use of (including mere access to) the website **www.springprofessional.be** operated by XPE Group NV and Adecco Professional Services NV (for more information: "Legal Info"), all with registered office at Noordkustlaan 16B, 1702 Groot-Bijgaarden, Belgium (hereinafter referred to as "Spring Professional", "we" or "us") including the content and services made available through this website (the "Website").
